### **Check before You Build – from the Kaman & Cusimano, LLC web site (<http://www.ohiocondolaw.com>)**

Porches, decks, landscape water falls, path lighting, window sheds, swimming pools, skylights, mailboxes, exterior light fixtures, hot tubs, and additions costing in the tens of thousands of dollars all have one thing in common. Each and every one has been installed in contradiction to an association's governing documents and each and every one was subsequently removed.

Association living is a choice that purchasers make. When an owner chooses association living, they are also choosing a lifestyle where individual desires must give way to community restrictions. Most associations have a restriction prohibiting any modification to the exterior of the home unless prior written approval of the board is obtained.

Before starting construction, put your intention in writing to your association's board and obtain written approval. Better to get prior approval than to waste hundreds or thousands of dollars installing and then removing an item. In the Georgetown Arms v. Super case, the Ohio Appeals Court stated that "individual owners cannot be permitted to disrupt the integrity of the common scheme through their desire for change."

### **Chuck Hillier - Volunteer Trustee**

We held our annual meeting on March 18th at the Metroparks Pavilion on Hardy Road, however per the requirements of our Code of Regulations, we failed to have a quorum present (minimum 50% of membership represented either physically or via proxy) so we were forced to suspend the meeting. We have gone ahead and scheduled another for Wednesday April 21st at 7 PM, once again to be held at the Metroparks Painesville Township Park building on Hardy Road.

Unfortunately, the low turnout at our first meeting means the rescheduled one will unnecessarily cost us additional monies (~\$400) as we must once again mail our entire membership notification and provide for hall rental. We considered holding the meeting at our park but if the weather doesn't cooperate we would once again have to reschedule and absorb even more costs.

If you were present at the meeting on March 18 or represented by proxy, you do not need to take any additional action. However, if you did not attend the March 18th meeting or did not send in your proxy to First Realty, please complete the proxy mailed to you and send it in as soon as possible, or plan to attend the rescheduled meeting on April 21, 2010.

Although we weren't able to conduct business or elect a new trustee at the March 18th meeting, we were able to hold discussions with the residents and introduce our management company personnel to those present. At the April 21st meeting, the trustee seat currently held by Michael DiSanto will be open for election. Michael has the option of running for his seat again if he

so chooses but regardless the seat is open and an election will take place. If you would like to run for the seat and serve your community, please consider throwing your name in the hat. The commitment is not extensive but does require some time and a dedication to serve your neighbors. We hope you'll consider.

Expenses for February totaled \$6,741.75. This amount was greatly comprised of our annual insurance payment along with closure of several legal bills for past actions. Year to date our expenses have slightly exceeded \$9,000 of a \$131,000 budget but our largest expenditure months are coming just around the corner when the weather breaks so things will balance out in the coming months.

## **NOTICE OF RESCHEDULED ANNUAL MEETING**

As many of you are aware, the Association held its Annual Meeting on March 18, 2010 at Painesville Township Park. Unfortunately, at that meeting, the Association was unable to establish a quorum of the membership and, as such, could not conduct the Annual Meeting, conduct Association business, or hold an election of Trustees. Therefore, the meeting was suspended until such time as a proper quorum is achieved.

The Association's governing documents require that a quorum of one-half of the voting power (i.e. 216 households) be present at the meeting or represented by proxy in order to properly conduct the Annual Meeting. To date, 154 households were present and/or represented by proxy. In order to establish the proper quorum, we need to have an additional 62 households present at the rescheduled meeting or represented by proxy to meet the required quorum number of 216 households.

It is very important that the Association conduct its Annual Meeting as soon as possible. Therefore, the Board of Trustees has agreed to reconvene the Annual Meeting on **April 21, 2010, at 7:00 p.m., at the Painesville Twp. Park. Sign-in will begin at 6:30 p.m.**

If you were present at the meeting on March 18 or represented by proxy, you do not need to take any additional action. However, if you did not attend the March 18<sup>th</sup> meeting or did not send in your proxy to First Realty, please complete the enclosed proxy and send it in as soon as possible, or plan to attend the rescheduled meeting on **April 21, 2010**. Each time the Annual Meeting is rescheduled, the Association incurs significant costs for postage, copying, hall rental, etc.

If you previously sent in your proxy, it will remain in effect for the rescheduled meeting.
